### **MINUTES**

# 1. CALL TO ORDER

Chair Dawn Tyler Lee called the meeting to order at 8:05 a.m.

President Stitt announced that the 11<sup>th</sup> Annual Statewide Tribute to Rosa Parks, hosted by COTA, The Ohio State University, and Congresswoman Joyce Beatty, will be held on December 3 and 4, 2015. He invited members of the Board to attend the events.

# 10. COMMITTEES

# A. OPERATIONS COMMITTEE - WILLIAM A. ANTHONY, CHAIR

<u>2015-97</u> - AUTHORIZING EXPENDITURES FOR THE CONTRACT WITH FIRST TRANSIT, INC. FOR TRANSPORTATION SERVICES FOR SENIORS AND INDIVIDUALS WITH DISABILITIES

Amy Hockman, Director, Mobility Services, presented this resolution. She said Resolution No. 2011-84 authorized a contract with First Transit, Inc. for transportation services for seniors and individuals with disabilities (ADA service) for the period commencing January 1, 2012 and expiring December 31, 2014, with an option to renew for up to two additional one-year terms. COTA wishes to renew this contract for the second additional one-year term, and expenditures to provide such services for the fifth year of the contract are required.

This resolution authorizes COTA to allocate the funds necessary for the provision of transportation services for seniors and individuals with disabilities provided by First Transit, Inc. for the period commencing January 1, 2016 and expiring December 31, 2016 for an estimated expenditure not to exceed Eight Million Four Hundred Twenty-Two Thousand Six Hundred Thirty-Four and 00/100 Dollars (\$8,422,634.00).

Treneff motioned to approve this resolution. Zitzke seconded the motion. Leach abstained. Motion passed.

# 2015-98 - AUTHORIZING FREE FARES DURING DECLARED SNOW EMERGENCIES

Lee Johnson, Interim Vice President, Operations, presented this resolution. He said the purpose of this Resolution is to provide customers with an alternative to driving during periods of severe weather, which causes traffic congestion through heavy and drifting snow and/or icy conditions, and below freezing temperatures.

This would apply only during an officially declared Level 2 and Level 3 Snow Emergencies authorized by the Franklin County Sheriff. Such declarations apply to both the city and county roadways. Level 2 and Level 3 Snow Emergencies will also involve restrictions on private vehicle traffic, thus making it more difficult for people to travel for work and other purposes. By providing "free" bus service during these periods, we would decrease traffic congestion, enhance public safety and provide the public with a tangible display of goodwill toward those who need to travel to their jobs, schools, and other locations.

This resolution authorizes COTA to offer free fares during Level 2 and 3 Snow Emergencies as declared by the Franklin County Sheriff. This free fare will stay in effect for the remainder of each day in which the snow emergency is declared.

Honsey motioned to approve this resolution. Leach seconded the motion. Motion passed
